Usage of images Anne Young, Young Reflections Photography, is an artist and, as such, requests that the work she creates be allowed into art exhibits, displayed, print competitions, and other places where her work is featured regularly. The work is always showcased in the best possible way and will never compromise or jeopardize the photographer's reputation. Confidentiality in advertising is always maintained.

I also agree that the photographer may use any images created during my commissioned session for display, advertisements, exhibits, sale, or trade or other use as deemed appropriate by Young Reflections Photography. Policies & Terms

- The session fee is due at the time of your session.
- You agree to hold harmless Anne Young, her representatives, employees, and Young Reflections Photography from any dispute if you become injured during the session. Young Reflections Photography and its representatives will not be held liable for any injury incurred or any damage to your property during the photo session.
- If you are looking to get very specific shots from your session, please send Young Reflections Photography example images one week in advance of the session.
- While Anne does capture many images during your session, you will see only those images selected by her, the artist, for previewing. I carefully render each image to ensure maximum artistry and technical perfection. Images with eyes closed, heads turned, duplicates, etc. will not be shown and will be removed from my archives permanently after the artist's rendering is complete.
- Payments may be made in cash, check, Visa, MasterCard, or American Express. A payment plan is available.
- Please allow four weeks for your order to be completed. Some orders may take longer. Your images are an investment and an heirloom that should not be rushed. If a handful of images are needed within 24 hours of the session, please send this shot-list to Anne prior to the session.
- All images are kept on file for a period of one year. After one year, it is your responsibility to preserve the images.
- You will receive your images in an online Google gallery. You may share the gallery link.
- The images in the link will be optimized for social media. It's always kind when you credit my company in your posts. High-resolution images are available upon request at no additional fee.
- No free reshoots will be granted due to clothing, weather, hair, or the subject's mood at the session. If you aren't feeling great on the day of the shoot, please reschedule before the shoot begins.
- Digital images can disappear in the blink of an eye. The most timeless method of preserving images is to print them. If you can't decide what to print, order all of them in 4x6. I recommend printing your photos from Mpix.com. Please, have at least some of them printed!
- Do not crop or re-edit the artist's work. If you have concerns about the images, please contact me. I will be happy to fix it or hand it off to a professional retoucher. Images will only be re-edited once, so be very clear about what you'd like changed about the image. The fee for re-editing is \$7 per image.
- The payee may use the images for profit. However, if another organization wants to use the images for profit, they must first purchase the rights to use each photo from Young Reflections Photography.
- The Copyright Act protects photographers by giving us the exclusive right to reproduce their photographs. Violations include, but are not limited to, making illegal copies, scanning, and printing from home. It is illegal to copy or reproduce these photographs in any manner without our permission and violators of this Federal Law will be subject to its civil and criminal penalties. Please understand, the photographer wishes to maintain complete control over the print quality, finishes and presentation of the images and any reproduction may lower the quality of the image and scar our reputation for providing superior portraits. (This basically means you can't print my images at a drugstore. Please print the images through a professional lab.)
